We also passed changed wording in the Membership section and in the Officers section. All officers will now be elected for two-year terms with term limits of two terms. 3. We are moving forward with plans to submit a proposal to the CSSA to co-host (with Gates C&SS) the 2015 Convention at Pitzer College. A steering committee has been appointed and you will hear more about this in the future.
4. Regarding the upcoming CSSA convention in San Diego (April 24 – 29), the club will once again help our members to attend. The

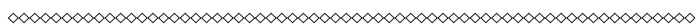

Plants Of The Month

Enter your specimen plants in our monthly mini-show. It will help you prepare for the real shows and give you an additional opportunity to show others your pride and joy. If you don't have any of these species of plants you can learn about them at the meeting.

CACTI and SUCCULENTS OF THE MONTH —

Miniatures

This month, the Cacti and Succulent of the Month are both miniatures. Miniatures are defined differently for different shows. In most cases, the definition is a mature plant in a pot with an inside diameter less than three inches. Some shows define the miniature category as any plant displayed as a miniature. This allows seedlings and young plants to be entered as miniatures. Others require the plant to be the smallest in a genus. We'll use the broad definition for the Plant of the Month: The inside dimension must be less than three inches, but anything else is allowed.

The miniature category is one of the most popular in our shows, with the number of entrants often one of the largest. The key to success is staging plants. Particular attention must be paid to the relation of the plant to the pot, the top dressing, and any rocks. The importance of color, geometry, and texture are all magnified in the smaller scale of miniatures.

Succulents entered as miniatures include representatives from almost every family, and a list would be far too long to print. Unusual entries often do well. Many *Haworthia* do fit, as do *Lithops*, *Conophytum* and many of the other smaller mesembs. Small *Crassulaceae* also do well.

With care, species that normally grow large can be kept small, by controlling root development. Even though small, miniatures need a little fertilizer to keep top growth looking fresh and frequent watering, since there is little storage either in the pot or the body of the plant.

Some Cacti suitable as miniatures:

Ariocarpus kotschoubeyanus - the classic entry
Blossfeldia - a genus of miniature cacti from Brazil
Epithelantha micromeris a variable species from Texas and Northern Mexico.

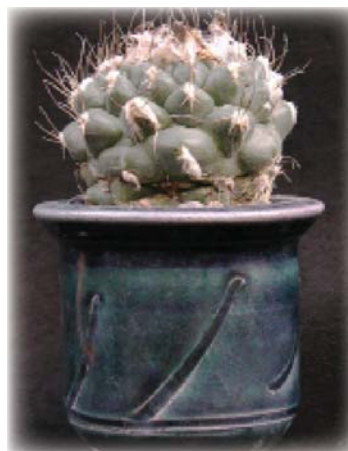
Frailea - a genus of small cacti, some of which clump.

Mammillaria saboae (discovered by club member Kitty Sabo!)

Mammillaria herrerae

Mammillaria hernandezii is a particularly beautiful species from Oaxaca.

Peleciphora asseliformis another classic from Mexico.



Turbincarpus lauii

Turbincarpus another genus of slow growing, small cacti from Mexico. There are many great species in this genus, all small and all worth growing.

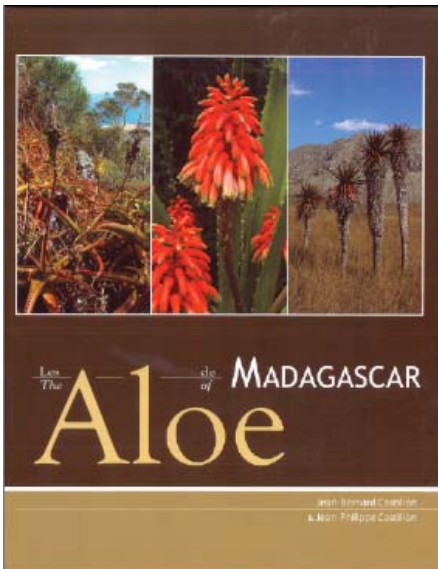

Book Review

The Aloes of Madagascar / Les Aloe de Madagascar

Interest in the genus *Aloe* has always been strong, and this is reflected currently by a sudden burst of activity in publications dedicated to the genus. Since Reynolds' two magnificent volumes, enthusiasts have had to hunt through numerous journals in many languages to keep

up with publication of new taxa. This volume by the father-and-son team from Reunion will be eagerly sought out by all who love this genus, the first dedicated exclusively to species from Madagascar and the Mascarene Islands.

The book, with both French and English text, begins with a useful introduction and glossary, so the reader will be familiar with terms used later. A short section on taxonomy concludes with several changes of status that the reader may or may not agree with, depending on their particular views on lumping or splitting. There are a few inconsistencies here. Comments made later in the text, that a particular species is really only a form of another species (e.g. *Aloe makayana* and *A. imalotensis*), yet no formal reduction to synonymy is made.

Descriptions of the 110 species are organized according to their distribution, and this is perhaps my biggest criticism of the book. Unless one knows the region that a particular plant originates from, it is necessary to use the index to locate it. Species are not even in alphabetical order within each region. Maps in the book are rather poor, and much could have been gained, without revealing locality details, by the addition of better distribution maps. Even those delineating the various regions have no place names.

Each species is lavishly illustrated, usually with close-up details of flowers and leaves to go with more general images of habitat, where appropriate. Often, multiple variations of a particular species are illustrated, but disappointingly, no efforts are made to indicate where a particular form originated. There are also illustrations of plants in cultivation, but this is not noted explicitly.

With its 1100 color pictures, the book is a remarkable catalog of what is unfortunately a rapidly changing part of our planet. Nobody with even the slightest interest in *Aloes* could resist leafing through its pages and probably finding a plant they have never heard of, but most likely will want to obtain. At the time of writing, it is only available directly from the authors (<http://www.aloe-de-madagascar.com/>). It is worth getting together with friends to order several copies and save on the cost of shipping which is considerable, but very, very well worth it.

The Membership will be asked to vote and approve the changes to the By-laws as approved by the Board of Directors at its regularly scheduled meeting held on January 19, 2011. Changes are noted with underlined words and the entire Article 13 is added.

Article 3 – Membership and Dues

Section 3. Annual dues shall be paid at a rate determined by Executive Board. Membership will run from January to December of the same year and shall lapse if not renewed by the February meeting. Reinstatement to regular membership will only be made by full payment of annual dues to the Treasurer. New member payments made at or after the National Show CSSA Show and Sale will cover dues of the current and the next year.

Article 4 – Officers

Section 1. The officers of the Society shall be President, Vice-President, Recording Secretary and Treasurer. Their term of office shall be ~~one~~ two calendar years.

Article 13 Amendment to the By-laws

Requirements to be exempt as an Organization

Described in section 501 (c)(3) of the internal Revenue Code

Section 1. Said organization is organized exclusively for charitable, educational, or scientific purposes, including, for such purposes, the making of distributions to organizations that qualify under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Section 2. No part of the net earnings of the organization shall inure to the benefit of, or be distributed to its members, trustees, officers, or other private per-

sons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause above.

Section 3. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for office.

Section 4. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c)(2) of the Internal revenue Code, or the corresponding section of any future federal tax code.

Section 5. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
